Ordinance No. 16, S-2019

AN ORDINANCE AUTHORIZING SUPPLEMENTAL BUDGET NO. 4 (REVERSION) FOR CY 2019 OF THE MUNICIPALITY OF BACOLOR, PAMPANGA IN THE TOTAL AMOUNT OF THREE MILLION EIGHT HUNDRED EIGHTY THREE THOUSAND EIGHT HUNDRED FIFTY EIGHT PESOS (P3,883,858.00) FROM UNFILLED POSITION (JANUARY TO OCTOBER) TO BE APPROPRIATED TO MAYOR'S OFFICE (OTHER MAINTENANCE AND OPERATING EXPENSE (OMOE)), SPA – ADMINISTRATIVE SERVICES (CULTURAL PROGRAM), MAINTENANCE OF MOTOR VEHICLE (GAS AND OIL LUBRICANT EXPENSES), MAINTENANCE OF BUILDING (REPAIR AND MAINTENANCE OF BUILDING AND ELECTRICITY) AND SPA – OTHERS (OTHER MAINTENANCE AND OPERATING EXPENSES)

BE IT ORDAINED, by the Sangguniang Bayan of Bacolor, Pampanga in session assembled, upon motion of Hon. Voltaire J. San Pedro, duly seconded by Hon. Ener C. Lampa

Section 1. The Supplemental Budget No. 3 of the Municipality of Bacolor, Pampanga Government for Fiscal Year 2019 in the total amount of Three Million Eight Hundred Eighty Three Thousand Eight Hundred Fifty Eight Pesos (P3,883,858.00) for Mayor's Office (Other Maintenance and Operating Expense (OMOE)), SPA – Administrative Services (Cultural Program), Maintenance of Motor Vehicle (Gas and Oil Lubricant Expenses), Maintenance of Building (Repair and Maintenance of Building and Electricity) and SPA – Others (Other Maintenance and Operating Expenses) is hereby approved.

The budget documents consisting of the following are incorporated herein and made integral part of this ordinance:

2. Statement of Supplemental Appropriation

Section 2. Source of funds. The sources of funds for the Supplemental Budget in the total amount of Three Million Eight Hundred Eighty Three Thousand Eight Hundred Fifty Eight Pesos (P3,883,858.00) from unfilled position (January to October).

Section 3. Use of Funds. The amount of Three Million Eight Hundred Eighty Three Thousand Eight Hundred Fifty Eight Pesos (P3,883,858.00) to Mayor's Office (Other Maintenance and Operating Expense (OMOE)), SPA – Administrative Services (Cultural Program), Maintenance of Motor Vehicle (Gas and Oil Lubricant Expenses), Maintenance of Building (Repair and Maintenance of Building and Electricity) and


