Ordinance No. 15, S-2020

AN ORDINANCE AUTHORIZING SUPPLEMENTAL BUDGET NO. 04 (REVERSION) FOR CY 2020 OF THE MUNICIPALITY OF BACOLOR, PAMPANGA IN THE TOTAL AMOUNT OF THREE MILLION SIX HUNDRED NINETY THOUSAND PESOS (P3,690,000.00) FROM THE SAVINGS FROM THE UNFILLED POSITION TO THE FINANCIAL ASSISTANCE GRANT (FAG)

BE IT ORDAINED, by the Sangguniang Bayan of Bacolor, Pampanga in session assembled, upon motion of Hon. Voltaire J. San Pedro, unanimously seconded

Section 1. The Supplemental Budget No. 4 of the Municipality of Bacolor, Pampanga Government for Fiscal Year 2020 in the total amount of Three Million Six Hundred Ninety Thousand Pesos (P3,690,000.00) for Financial Assistance Grant (FAG) is hereby approved.

The budget documents consisting of the following are incorporated herein and made integral part of this ordinance:

1. Statement of Funding Sources
2. Statement of Supplemental Appropriation

Section 2. Source of funds. The sources of funds for the Supplemental Budget in the total amount of Three Million Six Hundred Ninety Thousand Pesos (P3,690,000.00) from the savings from the unfilled position.

Section 3. Use of Funds. The amount of Three Million Six Hundred Ninety Thousand Pesos (P3,690,000.00) to Financial Assistance Grant (FAG) is hereby appropriated for the Supplemental Budget of the Municipality of Bacolor, Pampanga, shall be intended to the following:

Total:	P3,690,000.00

Section 4. Separability Clause. If, for any reason, any section or provision of this Ordinance is declared invalid or unconstitutional, other sections or provisions thereof which are not affected thereby shall continue to be in full force and effect.




