Ordinance No. 17, S-2021

AN ORDINANCE AUTHORIZING SUPPLEMENTAL BUDGET NO. 05 FOR CY 2021 OF THE MUNICIPALITY OF BACOLOR, PAMPANGA IN THE TOTAL AMOUNT OF SEVEN MILLION PESOS (P7,000,000.00) FROM THE UNDER ESTIMATED REVENUES TO SPECIAL PURPOSE APPROPRIATIONS (SPA) – BUDGETARY REQUIREMENT (5% CALAMITY FUND, 5% GAD, 1% SCs/PWDs, 1% LCPC), SPECIAL PURPOSE APPROPRIATIONS (SPA) - SOCIAL SERVICES (ASSISTANCE IN CRISIS SITUATION (SENIOR CITIZENS)), SPECIAL PURPOSE APPROPRIATIONS (SPA) – OTHERS OTHER MAINTENANCE AND OPERATING EXPENSES (OMOE) AND SANGGUNIANG BAYAN – GENERAL SERVICES

BE IT ORDAINED, by the Sangguniang Bayan of Bacolor, Pampanga in session assembled, upon motion of Hon. Voltaire J. San Pedro, unanimously seconded

Section 1. The Supplemental Budget No. 5 of the Municipality of Bacolor, Pampanga Government for Fiscal Year 2021 in the total amount of Seven Million Pesos (P7,000,000.00) for Special Purpose Appropriations (SPA) – Budgetary Requirement (5% Calamity Fund, 5% GAD, 1% SCs/PWDs, 1% LCPC), Special Purpose Appropriations (SPA) - Social Services (Assistance In Crisis Situation (Senior Citizens)), Special Purpose Appropriations (SPA) – Others Other Maintenance and Operating Expenses (OMOE) and Sangguniang Bayan – General Services is hereby approved.

The budget documents consisting of the following are incorporated herein and made integral part of this ordinance:

1. Statement of Funding Sources
2. Statement of Supplemental Appropriation

Section 2. Source of funds. The sources of funds for the Supplemental Budget in the total amount of Seven Million Pesos (P7,000,000.00) from the Under Estimated Revenues.

Section 3. Use of Funds. The amount of Seven Million Pesos (P7,000,000.00) is hereby appropriated for the Supplemental Budget of the Municipality of Bacolor, Pampanga, shall be intended to the following:




Section 5. Effectivity. The provisions of this Ordinance shall take effect upon approval
