A RESOLUTION REQUESTING THE PROVINCIAL GOVERNOR, HON. LILIA G. PINEDA TO ALLOCATE FUNDS FOR THE IMMEDIATE REPAIR OF THE TWO-STOREY SCHOOL BUILDING OF SAN ISIDRO HIGH SCHOOL LOCATED AT SAN ISIDRO, BACOLOR, PAMPANGA

WHEREAS, San Isidro High School had been using this two-storey school building for 31 years, evidenced by its old structure and deteriorating building materials;

WHEREAS, the School Administrators and PTA had a strong fear on the safety and security of the students, for the possible breakdown/collapse or falling debris from the building that might cause danger to the lives of the students and teachers;

WHEREAS, the school administration had no sufficient funds for the immediate repair and rehabilitation of the old building for a conducive and safe learning place for students;

NOW THEREFORE, upon motion of Hon. Wilfredo H. Balingit, unanimously seconded;

RESOLVED AS IT IS HEREBY RESOLVED to request the Provincial Governor, Hon. Lilia G. Pineda to allocate funds for the immediate repair of the two-storey school building of San Isidro High School located at San Isidro, Bacolor, Pampanga;


RESOLVED FINALLY, that a copy of this resolution be furnished to the Hon. Lilia G. Pineda, Provincial Governor for her ready reference.
