Resolution No. 63, S-2014

A RESOLUTION REQUESTING THE DEPARTMENT OF PUBLIC WORKS & HIGHWAYS (DPWH) AND THE MT. PINATUBO EMERGENCY-PROJECT MANAGEMENT OFFICE (MPE-PMO) AND CONCERNED GOVERNMENT AGENCIES TO TEMPORARILY STOP THE RE-CHANELLING OF CAMACHILE VENTURA RIVER ALONG BARANGAY TALBA FOR FAILURE TO CONDUCT THE NECESSARY PUBLIC CONSULTATION AS REQUIRED BY LAW

WHEREAS, the MPE-PMO is currently implementing the rehabilitation of Camachile Ventura River in Barangay Talba, Bacolor, Pampanga in an effort to solve the flooding problem in Bacolor and nearby towns;

WHEREAS, municipal and barangay officials of Bacolor have expressed concern on the absence of any public consultation initiated by MPE-PMO to determine the pulse of affected inhabitants on the proposed project;

WHEREAS, many officials of Bacolor believe that the project being initiated by MPE-PMO is intended to protect the towns of Sto. Tomas, Minalin and City of San Fernando compared with Bacolor;

WHEREAS, many residents of Bacolor are being bothered by the implementation of said project, which will trigger right of way problem and will jeopardize the existing topographical set-up of Barangay Talba, which is undergoing rehabilitation following the eruption of Mt. Pinatubo;


NOW THEREFORE, the Sangguniang Bayan of Bacolor, Pampanga in session assembled upon motion of Hon. Nilo M. Caballa, unanimously seconded that;

RESOLVED, as it is hereby resolved to request the Department of Public Works & Highways (DPWH) and Mt. Pinatubo Emergency-Project Management Office (MPE-PMO) and concerned government agencies to temporarily stop the re-channelling of Camachile Ventura River along Barangay Talba for failure to conduct the necessary public consultation as required by law;


RESOLVED FINALLY, that a copy of this resolution be presented to the Department of Public Works & Highways (DPWH) and Mt. Pinatubo Emergency - Project Management Office (MPE-PMO) for their reference.
