HENSON, PROVINCIAL BOARD MEMBERS OF THIRD DISTRICT OF PAMPANGA TO ALLOCATE FUNDS FOR THE CONCRETING OF THE PROVINCIAL ROAD FRONTING SAN GUILLERMO PARISH CHURCH IN SAN VICENTE, BACOLOR, PAMPANGA

WHEREAS, most of the barangay roads of Municipality of Bacolor, Pampanga, were destroyed when the town was inundated by lahar from 1991 to 1995;

WHEREAS, despite the lahar devastation, through hardwork, patience and resiliency of the Bacoloreños, the town of Bacolor is now on its path towards rehabilitation and redevelopment;

WHEREAS, many residents of barangay San Vicente, Bacolor, Pampanga have returned and are now rebuilding their homes and their lives and the concreting of their barangay road will enable them to have easy access to goods and services ;

NOW THEREFORE, the Sangguniang Bayan of Bacolor in Session assembled, upon unanimous motion;
