WHEREAS, the present state of Municipal Judge chamber/sala is in a deplorable condition learned from the pictures hereto attached and made integral part of this resolution;

WHEREAS, this kind of chamber/sala affect the dignity of the dispensation of justice;

WHEREFORE, the Sangguniang Bayan of Bacolor in session assembled upon motion of Hon. Efren S. Blanco, unanimously seconded;

RESOLVED to request Hon. Maria Lourdes P.A. Sereno, Chief Justice of the Supreme Court to provide funding assistance for the construction of the Municipal Trial Court in Bacolor, Pampanga,
