WHEREAS, the Municipal Mayor appointed Mrs. Glicería D. Espino last March 10, 2014 as Municipal Assessor in a "Permanent Capacity" and submitted to the Sangguniang Bayan said permanent appointment for concurrence;

WHEREAS, after the pertinent papers/documents for the appointment of Mrs. Glicería D. Espino have been submitted to the office of the Sangguniang Bayan, the Committee on Good Government, Public Ethics and Accountability conclusively established, based on the documents submitted, that all the necessary requirements for the appointment had been complied with, including the medical certification under CSC Form No. 211 issued by the attending physician recommending and signifying the fitness of the appointee and that should any document be found inconsistent with law, this concurrence will be revoked;

NOW THEREFORE, the Sangguniang Bayan of Bacolor, Pampanga in Regular Session assembled upon unanimous motion;

RESOLVED as it is hereby resolved, to concur with the appointment of Mrs. Glicería D. Espino as Municipal Assessor for the Municipality of Bacolor, Pampanga in a permanent status;
