YUMANG, ACTING MUNICIPAL TREASURER TO OPEN TWO (2) SEPARATE TRUST FUND ACCOUNTS FOR THE MUNICIPALITY WITH RESPECT TO THE TWO (2) DEVELOPMENT PROJECTS TO BE FUNDED BY THE ANGELES POWER INC. (API) IN ACCORDANCE TO THE ENERGY REGULATIONS NO. 1-94 OF THE DEPARTMENT OF ENERGY (DOE)

WHEREAS, the Municipality of Bacolor was granted two (2) development projects funded by the Angeles Power Inc. (API) in the total amount of Five Million Five Hundred Thousand Pesos (P5,500,000.00) intended for the Environmental Management (garbage trucks) and Development Livelihood Program (lighting of the Megadike)

WHEREAS, the Municipality of Bacolor need to open two (2) separate trust fund account for each development project;


