A RESOLUTION REQUESTING HONORABLE CONGRESSMAN AURELIO "DONG" A. GONZALES, JR. REPRESENTATIVE 3RD DISTRICT OF PAMPANGA THROUGH THE INITIATIVE OF HON. EDUARDO G. DATU, MUNICIPAL MAYOR FOR THE FUNDING ASSISTANCE OF THE CONCRETING OF POTRERO FARM TO MARKET ROAD INCLUDING ITS LOCATION SURVEY UNDER THE RA 9506 – OTHERWISE KNOWN AS "BACOLOR REHABILITATION ACT"

WHEREAS, most of the barangay roads including the farm to market road of barangay Potrero in the Municipality of Bacolor, Pampanga, were destroyed and buried by several feet of lahar after the eruption of Mt. Pinatubo in 1991;

WHEREAS, the Municipality of Bacolor had bounced back from its catastrophic past through the persevering efforts of government officials, resiliency of town folks and complimentary role of the private sector;

WHEREAS, many residents of Barangay Potrero and nearby barangay, particularly barangay Maliwalu, Bacolor, Pampanga have returned to their homeland and started rebuilding their homes and tilling their once lahar-buried agricultural lands;

WHEREAS, the concreting of barangay farm to market road of barangay Potrero will undoubtedly provide farmers easy, accessible and comfortable road linkages to their harvest market destinations;


NOW THEREFORE, the Sangguniang Bayan of Bacolor in session assembled, upon unanimous motion.

RESOLVED AS IT IS HEREBY RESOLVED, to request Honorable Congressman Aurelio "Dong" A. Gonzales, Jr. representative 3rd District of Pampanga through the initiative of Hon. Eduardo G. Datu, Municipal Mayor for the funding assistance of the concreting of Potrero Farm to Market road including its location survey under the RA 9506 – otherwise known as "Bacolor Rehabilitation Act"
