A RESOLUTION REQUESTING THE DEPARTMENT OF PUBLIC WORKS & HIGHWAYS (DPWH) TO ALLOCATE FUNDS FOR THE REPAIR AND CONSTRUCTION OF THE DAMAGED SLOPE PROTECTION OF SAPANG CABALANTIAN CREEK LOCATED IN BARANGAY CABALANTIAN BACOLOR, PAMPANGA

WHEREAS, the Sapang Cabalantian Creek is one of the major existing creeks in barangay Cabalantian and it was rehabilitated by the Department of Public Works and Highways (DPWH) almost a year ago;

WHEREAS, during rainy season, the creek was continuously damaged by the volume of rain water, the 30-40 length damage of Sapang Cabalantian Creek caused fears and worryness to the residents for the possible damage on their properties and safety of the constituents;

WHEREAS, the Local Government of Bacolor has limited funds for its rehabilitation, in this regard, the local officials initiates the request for funding of the abovementioned project;


NOW THEREFORE, the Sangguniang Bayan of Bacolor in session assembled, upon unanimous motion.

RESOLVED AS IT IS HEREBY RESOLVED, to request the Department of Public Works and Highways (DPWH) to allocate funds for the repair and construction of the damaged slope protection of Sapang Cabalantian Creek located in barangay Cabalantian, Bacolor, Pampanga.


