A RESOLUTION REQUESTING HON. AURELIO "DONG" GONZALES JR., CONGRESSMAAN 3RD DISTRICT OF PAMPANGA TO PROVIDE FUNDING ASSISTANCE FOR THE CONSTRUCTION OF DRAINAGE SYSTEM AT ZONE 1 TO 6 INCLUDING SITO BANLIC IN BARANGAY CABALANTIAN, BACOLOR, PAMPANGA TO RESOLVE THE FLOODING PROBLEM OF ITS RESIDENTS

WHEREAS, during rainy season, the residents of Barangay Cabalantian are complaining and having difficulty passing along the flooded roads caused by stagnant rain water particularly, in front of St. Joseph Chapel;

WHEREAS, the main problem is the absence of a drainage system to absorb the rain water and free the roads from floodings;

WHEREAS, the Barangay Officials and the Local Government of Bacolor has no allotted funds for its construction for they have limited budgets;


NOW THEREFORE, the Sangguniang Bayan of Bacolor in session assembled, upon motion of Hon. Emily Batac-Valerio, duly seconded by Hon. Jo Derek P. Hizon.

RESOLVED AS IT IS HEREBY RESOLVED, to request Hon. Aurelio "Dong" Gonzales, Congressman, Third District of Pampanga to provide funding assistance for the construction of the drainage system at Zone 1 to 6 including Sitio Banlic in Barangay Cabalantian, Bacolor, Pampanga to resolve the flooding problem of its residents.
