**A RESOLUTION APPROVING THE ANNUAL INVESTMENT PROGRAM (AIP) FOR CY 2020 OF THE CONSISTING OF PRIORITY PROGRAMS/PROJECTS TO BE FUNDED UNDER THE 20% ECONOMIC DEVELOPMENT FUND (EDF) AMOUNTING TO TWENTY FOUR MILLION SIX HUNDRED SIXTY NINE THOUSAND SEVEN HUNDRED SEVENTY TWO PESOS AND EIGHTY CENTAVOS (P24,669,772.80) AND THOSE TO BE FUNDED BY EXTERNAL SOURCES AMOUNTING TO ONE BILLION NINE HUNDRED FORTY ONE MILLION FIVE HUNDRED THOUSAND PESOS (P1,941,500,000.00) OR AN AGGREGATE AMOUNT OF ONE BILLION NINE HUNDRED SIXTY SIX MILLION ONE HUNDRED SIXTY NINE THOUSAND SEVEN HUNDRED SEVENTY TWO PESOS AND EIGHTY CENTAVOS (P1,966,169,772.80) FOR BOTH 20% EDF AND EXTERNAL SOURCES**

**RESOLVED AS IT IS HEREBY RESOLVED**, that the Annual Investment Plan for CY 2020 of the consisting of priority programs/projects to be funded under the 20% Economic Development Fund (EDF) amounting to Twenty Four Million Six Hundred Sixty Nine Thousand Seven Hundred Seventy Two Pesos and Eighty Centavos (P24,669,772.80) and those to be funded by External Sources amounting to One Billion Nine Hundred Forty One Million Five Hundred Thousand Pesos (P1,941,500,000.00) or an aggregate amount of One Billion Nine Hundred Sixty Six Million One Hundred Sixty Nine Thousand Seven Hundred Seventy Two Pesos and Eighty Centavos (P1,966,169,772.80) for both 20% EDF and External Sources be approved in accordance with the requirements set forth under the Local Government Code.
