**WHEREAS**, the 1991 Mt. Pinatubo eruption and the series of lahar avalanches from thereon until 1998, totally devastated 20 out of 21 barangays of Bacolor;

**WHEREAS**, the Municipality of Bacolor has been struggling for more than twenty eight (28) years after the tragic deluge suffered by the people of Bacolor;

**WHEREAS**, many of our constituents returned back from the different resettlement areas provided by the government and started tilling their agricultural lots as means of their livelihood;

**WHEREAS**, living in remote places where no available medical facilities added burdens to the poor condition and situation of our constituents;

**WHEREAS**, the Internal Revenue Allotment (IRA) of our LGU is insufficient to address all the basic services needed by the people;


**WHEREAS**, the presence of an ambulance will be of great help to our Cabalens and keep them away from any possible danger and can immediately attend in their medical needs;
