A RESOLUTION AUTHORIZING HON. EDUARDO G. DATU, MUNICIPAL MAYOR FOR AND IN BEHALF OF THE MUNICIPALITY OF BACOLOR TO ENTER INTO A DEED OF DONATION WITH THE PROVINCIAL GOVERNMENT OF PAMPANGA, REPRESENTED BY HON. DENNIS G. PINEDA, IN HIS CAPACITY AS GOVERNOR OF PAMPANGA, FOR THE DONATION OF ONE (1) UNIT DUMP TRUCK 4X2, TO BE USED IN THE IMPLEMENTATION AND ENFORCEMENT OF THE COLLECTION AND HAULING OF MUNICIPAL WASTE IN OUR MUNICIPALITY

WHEREAS, in the interest of public service, the Municipal Mayor in his letter request dated October 8, 2019 requested the Sangguniang Bayan of Bacolor to authorize him for and in behalf of the Municipality of Bacolor to enter into a Deed of Donation with the Provincial Government of Pampanga, represented by Hon. Dennis G. Pineda, Governor;

WHEREAS, the donation of one (1) unit hurricane dump truck 4x2 will be used for the implementation and enforcement of the Collection and Hauling of Municipal Waste in the Municipality of Bacolor, Pampanga;

WHEREAS, the obligation of the Local Government Unit of Bacolor, under the Deed of Donation is to maintain the vehicle in a constant good condition and save it for ordinary wear and tear.
