**A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. EDUARDO G. DATU, GEO.,MPM TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) FOR AND IN BEHALF OF THE MUNICIPALITY OF BACOLOR, PAMPANGA WITH THE DEVELOPMENT BANK OF THE PHILIPPINES (DBP) FOR THE SALARY LOAN FACILITY OF LGU OFFICIALS AND EMPLOYEES**

**WHEREAS**, DBP has launched a salary loan facility to provide financial assistance in the form of salary loans to qualified officers and employees of the local government unit;

**WHEREAS**, the "LGU Bacolor" in consideration of DBP's agreement to extend salary loan facility has agreed to fulfill certain obligations relative to its accreditation, the eligibility of the borrowers, and the remittance to DBP of the monthly amortization due, in accordance with the Salary Loan Facility (SLF) guidelines;


