A RESOLUTION REQUESTING THE NATIONAL IRRIGATION AUTHORITY (NIA) FOR THE REHABILITATION OF THE IRRIGATION CANAL AT THE NORTHERN PORTION OF THE PASIG-POTRERO RIVER CONNECTING TO THE DOWNSTREAM BARANGAYS MALIWALU, DOLORES, POTRERO, DUAT, SAN ANTONIO, STA. BARBARA AND CABETICAN TO BOOST AGRICULTURAL FARMING WITHIN THE MUNICIPALITY OF BACOLOR

WHEREAS, the irrigation canal from Potrero down to Cabetican was constructed and funded under the Bacolor Rehabilitation Act of 2008 through the help of Congressman Aurelio "Dong" Gonzales, Jr., 3rd District representative, Province of Pampanga;

WHEREAS, the said irrigation canal was damaged by heavy rains and flooding which struck our Municipality in the past years;

WHEREAS, through the effort and initiative of the Local Government Unit of Bacolor, the residents of barangays Maliwalu, Dolores, Potrero, Duat, San Antonio, Sta. Barbara and Cabetican, the funding of the rehabilitation of the aforementioned irrigation canal is highly requested to the National Irrigation Administration (NIA) to help the farmers to have a high agricultural yield;

NOW THEREFORE, the Sangguniang Bayan of Bacolor in session assembled, upon motion of Hon. Ariel C. Sta. Cruz, unanimously seconded


