**Resolution No. 139, S-2019**

**A RESOLUTION ADOPTING R.A. 8172 OTHERWISE KNOWN AS "ACT FOR SALT IODIZATION NATIONWIDE (ASIN) IN THE MUNICIPALITY OF BACOLOR, PAMPANGA**

**WHEREAS**, as general rule, the state shall promote and protect the health of its people;

**WHEREAS**, as provided under R.A. 8172 Section 3 paragraph d.) require the local government units (LGU), through their health officers and nutritionist/dietitians, or in their absence through their sanitary inspectors, to check and monitor the quality of food-grade salt being sold in their market in order to ascertain that such salt is properly iodized;

**WHEREAS**, the Local Government Unit of Bacolor adheres to this policy of the state as provided in this Act in order to eliminate malnutrition in the municipality.

**NOW THEREFORE**, the Sangguniang Bayan of Bacolor in session assembled, upon motion of Hon. Emily Batac-Valerio, duly seconded by Hon. Ariel C. Sta. Cruz
