Resolution No. 140, S-2019

A RESOLUTION ADOPTING R.A. 8976 OTHERWISE KNOWN AS "AN ACT ESTABLISHING THE PHILIPPINE FOOD FORTIFICATION PROGRAM AND FOR OTHER PURPOSES" IN THE MUNICIPALITY OF BACOLOR, PAMPANGA

WHEREAS, R.A. 8976 is an act mandating the fortification of staple foods and voluntary fortification of processed foods or foods products;

WHEREAS, the local government unit of Bacolor recognizes that food fortification is considered important in the promotion of optimal health and to compensate for the loss of nutrients due to processing and/or storage of food;

WHEREAS, under Section 15 of Article 11 of the Philippine Constitution provides that the state shall protect and promote the right of health of the people and instill health consciousness among them;

NOW THEREFORE, the Sangguniang Bayan of Bacolor in session assembled, upon motion of Hon. Emily Batac-Valerio, duly seconded by Hon. Ariel C. Sta. Cruz

RESOLVED AS IT IS HEREBY RESOLVED, to adopt 8976 otherwise known as "An act establishing the Philippine Food Fortification Program and for other purposes" in the Municipality of Bacolor, Pampanga.
