A RESOLUTION ADOPTING THE DEPARTMENT OF HEALTH (DOH) ADMINISTRATIVE ORDER (AO) NO. 2010-10 REGARDING THE REVISED POLICY ON MICRONUTRIENT SUPPLEMENTATION TO SUPPORT ACHIEVEMENT OF 2015 MDG TARGETS TO REDUCE UNDERFIVE AND MATERNAL DEATHS AND ADDRESS MICRONUTRIENT NEEDS OF OTHER POPULATION GROUPS IN THE MUNICIPALITY OF BACOLOR, PAMPANGA

1. Guide health workers and providers in administering micronutrient supplements to identified population groups and client needs;
