Resolution No. 03, S-2021

A RESOLUTION REQUESTING THE DEPARTMENT OF EDUCATION (DEPED) PAMPANGA FOR THE CONVERSION OF BACOLOR ELEMENTARY SCHOOL-PROPER INTO AN INTEGRATED SCHOOL TO BE NAMED AND KNOWN AS BACOLOR INTEGRATED SCHOOL, SUBJECT TO ALL EXISTING LAWS, RULES AND REGULATIONS

WHEREAS, under Section 1, Article XIV of the 1987 Philippine Constitution provides that "The State shall protect and promote the right of all citizens to quality education at all levels, and shall take appropriate steps to make such education accessible to all";

WHEREAS, under Section 17 of the Local Government Code of 1991 Republic Act No. 7160 provides that "Local Government Units shall provide basic services and facilities including the establishment of the school building";

WHEREAS, education is one of the priority trust of the Local Government Unit of Bacolor to provide its people a quality education;

WHEREAS, the Department of Education (DepEd) – Schools Division of Pampanga is in the process of securing, finalizing and consolidating pertinent documents for the conversion of the abovementioned school into integrated school;

WHEREAS, based on the guidelines and one of the requirements of the Department of Education (DepEd) for the said conversion is the renaming of the school to an Integrated School;

WHEREAS, the Sangguniang Bayan agreed to pass a resolution requesting for the conversion of the mention school into Integrated School subject to all existing laws, rules and provisions;

NOW THEREFORE, the Sangguniang Bayan of Bacolor in session assembled, upon motion of Hon. Danlohp D. Danganan, duly seconded by Hon. Ariel C. Sta. Cruz

RESOLVED AS IT IS HEREBY RESOLVED, to request the Department of Education (DepEd) for the conversion of Bacolor Elementary School-Propor into an Integrated School to be named and known as Bacolor Integrated School, subject to all existing laws, rules and regulations
