A RESOLUTION APPROVING BARANGAY APPROPRIATION ORDINANCE NO. 2, S-2020 – AN ORDINANCE AUTHORIZING FOR BUDGET SUPPLEMENTAL TAX REVENUE FROM QUARRY SHARE FOR THE YEAR 2020 IN THE AMOUNT OF FIVE HUNDRED EIGHTY SEVEN THOUSAND SEVEN HUNDRED FORTY THREE PESOS AND NINETY SIX CENTAVOS (P587,743.96) TO PERSONAL SERVICES, MAINTENANCE AND OTHER OPERATING EXPENSES (MOOE), CAPITAL OUTLAY AND NON-OFFICE BUDGETARY REQUIREMENTS OF BARANGAY MESALIPIT, BACOLOR, PAMPANGA

RESOLVED AS IT IS HEREBY RESOLVED, that Barangay Appropriation Ordinance No. 2, S-2020 – An ordinance authorizing for Budget Supplemental Tax Revenue from quarry share for the year 2020 in the amount of Five Hundred Eighty Seven Thousand Seven Hundred Forty Three Pesos And Ninety Six Centavos (P587,743.96) to Personal services, Maintenance and Other Operating Expenses (MOOE), Capital Outlay and Non-office budgetary requirements of barangay Mesalipit, Bacolor, Pampanga was approved pursuant to the certification issued by the Municipal Budget Officer dated December 10, 2020 that the same was checked for computation and conforms with DBM regulations and was recommended for approval.
