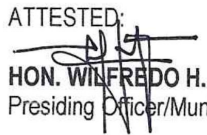
**RESOLVED FINALLY**, that a copy of this resolution be furnished to the Barangay Council of Cabetican and Office of the Mayor for their ready reference.
