**A RESOLUTION APPROVING BARANGAY APPROPRIATION ORDINANCE NO. 03, S-2020 – AN ORDINANCE AUTHORIZING FOR BUDGET REVERSION THE REMAINING BALANCE FOR 20% ECONOMIC DEVELOPMENT FUND AND MAINTENANCE AND OTHER OPERATING EXPENSES (MOOE) AMOUNTING TO TWO HUNDRED THIRTY NINE THOUSAND TWO HUNDRED FIFTY TWO PESOS AND FIFTY CENTAVOS (P239,252.50) FOR THE ANNUAL BUDGET 2020 TO 5% CALAMITY FUND OF BARANGAY CABETICAN, BACOLOR, PAMPANGA**

**RESOLVED AS IT IS HEREBY RESOLVED**, that Barangay Appropriation Ordinance No. 03, S-2020 – An ordinance authorizing for Budget Reversion the remaining balance for 20% Economic Development Fund and Maintenance and Other Operating Expenses (MOOE) amounting to Two Hundred Thirty Nine Thousand Two Hundred Fifty Two Pesos and Fifty Centavos (P239,252.50) for the Annual Budget 2020 to 5% Calamity Fund of Barangay Cabetican, Bacolor, Pampanga was approved pursuant to the certification issued by the Municipal Budget Officer dated December 29, 2020 that the same was checked for computation and conforms with DBM regulations and was recommended for approval.
