**Resolution No. 11, S-2021**

**A RESOLUTION EXTENDING THE PAYMENT OF BUSINESS TAXES UNTIL FEBRUARY 20, 2021 IN THE MUNICIPALITY OF BACOLOR, PAMPANGA**

**WHEREAS**, the New Local Government Code (R.A 7160) under Section 167 states that "all local taxes, fees, and charges shall be paid within the first twenty (20) days of January or every subsequent quarter, as the case may be. The sanggunian concerned may, for a justifiable reason or cause, extend the time for payment of such taxes, fees, or charges without surcharges or penalties, but only for a period not exceeding six (6) months";

**WHEREAS**, aforesaid provision was adopted and reflected under the Local Revenue Code of the Municipality under Section 2C.03;

**WHEREAS**, based on the records of the Municipal Treasury of Bacolor, Pampanga, the turned out of taxpayers is not as expected due to the effect of COVID-19 pandemic;

**WHEREAS**, the Sangguniang Bayan considered the abovementioned records a justifiable reason to extend the time of payment of taxes without surcharge or penalties to accommodate all the tax payers pursuant to the abovementioned provision of the Local Government Code;


**NOW THEREFORE**, the Sangguniang Bayan of Bacolor in session assembled, upon motion of Hon. Voltaire J. San Pedro, seconded by Hon. Ener C. Lampa.

**RESOLVED AS IT IS HEREBY RESOLVED**, to extend the payment of business taxes until February 20, 2021 in the Municipality of Bacolor, Pampanga.

**RESOLVED FINALLY**, that a copy of this resolution be furnished to the Office of the Municipal Treasurer and Hon. Eduardo G. Datu, Municipal Mayor for their ready reference.
