A RESOLUTION ENDORSING TO THE DEPARTMENT OF BUDGET AND MANAGEMENT (DBM) THE PROJECT: "IMPROVEMENT/UPGRADING/CONCRETING OF SAN ISIDRO BARANGAY ROAD WITH DRAINAGE CANAL AND BOX CULVERT" AMOUNTING TO FIFTEEN MILLION PESOS (P15,000,000.00), FOR FUNDING AND/OR RELEASE OF FUNDS UNDER THE FY 2021 LOCAL GOVERNMENT SUPPORT FUND – FINANCIAL ASSISTANCE TO LOCAL GOVERNMENT UNITS (LGSF-FALGU)
