A RESOLUTION AUTHORIZING HON. EDUARDO G. DATU, MUNICIPAL MAYOR, FOR AND IN BEHALF OF THE MUNICIPALITY OF BACOLOR, TO SIGN THE DEED OF ABSOLUTE SALE ON MUNICIPAL LOTS SITUATED IN BARANGAYS CABAMBANGAN, SAN VICENTE AND PARULOG, SOLD TO BE SUCCESSFUL BIDDERS AND AWARDEES PER ORDINANCE NO. 01, S-1987, AS AMENDED BY RESOLUTION NO. 56, S-1987

WHEREAS, the Local Government Code (RA 7160) requires the local chief executive to secure a written authorization from the Sangguniang Bayan to dispose these lots by way of Absolute Sale to successful bidders and awardees;

WHEREAS, there are certain municipal lots of relatively small areas situated in barangays Cabambangan, San Vicente and Parulog sold to successful bidders and awardees pursuant to existing municipal Ordinance No. 01, S-1987, as amended by Sangguniang Bayan Resolution No. 56, S-1987;

WHEREAS, the new owners of the aforesaid municipal lots with no outstanding balance needs a Deed of Absolute Sale to facilitate the transfer of their Certificate of Title (TCT) from the Municipality of Bacolor, Pampanga;

WHEREAS, the Municipality of Bacolor, represented by Hon. Eduardo G. Datu in its capacity as vendor, intends to deliver the transfer certificate of titles to these vendees, to establish the evidence of Absolute Ownership;
