A RESOLUTION APPROVING BARANGAY APPROPRIATION ORDINANCE NO. 01, S-2021 – AN ORDINANCE APPROPRIATING FUNDS FROM THE SAVINGS (UNUSED FUNDS FOR 2020) AND EXCESS OF COLLECTION FROM THE SHARES ON TAX ON GRAVEL AND SAND AND REAL PROPERTY TAX FEES AMOUNTING TO FIVE MILLION SEVEN HUNDRED THREE THOUSAND EIGHT HUNDRED TWENTY SEVEN PESOS AND SIXTY TWO CENTAVOS (P5,703,827.62) AND TO BE APPROPRIATED TO MAINTENANCE AND OTHER OPERATING EXPENSES, PURCHASE OF BARANGAY AMBULANCE, REHABILITATION OF BANGKAL BRIDGE, DECLOGGING LINED CANAL AND REHABILITATION OF BARANGAY CEMETERY FOR THE YEAR 2021 OF BARANGAY MALIWALU, BACOLOR, PAMPANGA

NOW THEREFORE, the Sangguniang Bayan of Bacolor in an online session assembled, upon motion of Hon. Voltaire J. San Pedro, duly seconded by Hon. Ener C. Lampa

RESOLVED AS IT IS HEREBY RESOLVED, that the Barangay Appropriation Ordinance No. 01, S-2021 – An ordinance appropriating funds from the savings (unused funds for 2020) and excess of collection from the Shares on Tax on Gravel and Sand and Real Property Tax Fees amounting to Five Million Seven Hundred Three Thousand Eight Hundred Twenty Seven Pesos and Sixty Two Centavos (P5,703,827.62) and to be appropriated to Maintenance and Other Operating Expenses, purchase of Barangay Ambulance, Rehabilitation of Bangkal Bridge, Declogging Lined Canal and Rehabilitation of Barangay Cemetery for the year 2021 of Barangay Maliwalu, Bacolor, Pampanga was approved pursuant to the certification issued by the Municipal Budget Officer dated June 3, 2021 that the same was checked for computation and conforms with DBM regulations and was recommended for approval.


