A RESOLUTION RECOGNIZING THE OFFICIAL SEAL OF VILLA DE BACOLOR, SIMON DE ANDA MONUMENT, JUAN CRISOSTOMO SOTO MONUMENT, PABLO ANGELES DAVID MONUMENT AND FELIX NAPAO GALURA MONUMENT AS LOCAL CULTURAL PROPERTIES OF THE MUNICIPALITY OF BACOLOR, PAMPANGA

WHEREAS, under Section 15, Article XIV of the 1987 Philippine Constitution provides that “The State shall conserve, promote and popularize the nation’s historical and cultural heritage and resources, as well as artistic creations;

WHEREAS, Section 2 of Republic Act No. 10066 otherwise known as the “National Cultural Heritage Act of 2006” mandates the protection, preservation, conservation and promotion of the nation’s cultural heritage, its property and history, and the ethnicity of the local communities. Specifically, Section 14 (b) and (c) of the said Act requires local government units to establish and maintain an inventory of cultural property;

WHEREAS, the Department of Interior and Local Government (DILG) and the National Commission for Culture and the Arts (NCAA) issued joint Memorandum Circular No. 2018-01, otherwise known as the “Local Inventory of Cultural Property as required under Republic Act No. 10066”, enjoining the Local Chief Executive to maintain a local inventory of all cultural property within their jurisdiction;

WHEREAS, the Municipal Tourism Office prepared and proposed a list of identified monuments and landmarks within the jurisdiction of Bacolor, Pampanga;

WHEREAS, the list of the Local Cultural monuments and landmarks are as follows:

2. Simon De Anda Monument
3. Juan Crisostomo Soto Monument
4. Pablo Angeles David Monument


