A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR AS CHAIRMAN OF THE MUNICIPAL NUTRITION COMMITTEE TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) FOR BNS PROJECT WITH THE NATIONAL NUTRITION COUNCIL REPRESENTED BY ITS EXECUTIVE DIRECTOR, DR. AZUCENA M. DAYANGHIRANG, FOR THE GRANT OF FINANCIAL SUPPORT IN THE AMOUNT OF TWENTY FIVE THOUSAND TWO HUNDRED PESOS (P25,200.00) FOR THE BARANGAY NUTRITION SCHOLARS PROJECT TO BE IMPLEMENTED BY THE LOCAL GOVERNMENT UNIT OF BACOLOR, PAMPANGA

WHEREAS, the Local Chief Executive requested the Sangguniang Bayan thru his letter dated July 5, 2021, to authorize him as Chairman of the Municipal Nutrition Committee to enter into a Memorandum of Agreement (MOA) for BNS Project with the National Nutrition Council represented by its Executive Director, Dr. Azucena M. Dayanghirang, for the grant of financial support in the amount of Twenty Five Thousand Two Hundred Pesos (P25,200.00) for the Barangay Nutrition Scholars Project to be implemented by our Local Government Unit;

WHEREAS, the following are the terms and conditions agreed by the **NATIONAL NUTRITION COUNCIL** referred to as the **COUNCIL** and the **MUNICIPAL NUTRITION COMMITTEE (Local Government Unit of Bacolor)** referred to as the **PROJECT PROPONENT** shall:

1. That the COUNCIL shall remit to the PROJECT PROPONENT the amount of Twenty-five thousand two hundred pesos: P 25, 200.00 (to be paid in cash)
2. That the PROJECT PROPONENT shall implement and conduct the project in accordance with the objectives, technical description, methodology and procedures, work schedules and other requirements embodied in the approved project proposal, a copy which is hereto attached as ANNEX "A" and made integral part of the Agreement;
3. That the PROJECT PROPONENT shall a) assure the appropriate use of the funds released under these agreement; b) maintain a complete financial record and submit such to the COUNCIL, together with the progress report of accomplishments, indicating fund releases, expenditures and status of the unexpected balances; c) make available to authorized agents/representatives of the COUNCIL any /all records, facilities, things pertinent to the project for inspection/examination/evaluation and d) that no funds shall be transferred from one item to another item without previous approval of the COUNCIL;
4. That the PROJECT PROPOSAL shall immediately return the amount(s) remitted by the COUNCIL in case of:

- a. non-appropriate use of funds released under this Agreement
- b. non-compliance of the requirements herein provided
- c. non-implementation of the project as approved project proposal
- d. violations of any of the conditions herein
- e. any unexpected balance at the end of the year

and shall further be liable to the COUNCIL for incidental fees, charge damages and/or expenses;

5. That this Agreement shall be for a period of 1 year from the day of signing thereof subject, however, to extension by mutual agreement of the parties hereto.

WHEREAS, this joint undertakings is highly beneficial to the constituents of the Municipality of Bacolor, Pampanga;


