## Resolution No. 113, S-2021

A RESOLUTION EARNESTLY REQUESTING ENGR. ROSELLER A. TOLENTINO, REGIONAL DIRECTOR, DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH) REGION III, TO PROVIDE MUCH-NEEDED ASSISTANCE FOR THE IMMEDIATE IMPLEMENTATION OF THE FOLLOWING INFRASTRUCTURE PROJECTS TO ADDRESS THE PERENNIAL FLOODING PROBLEM ALONG THE DOWNSTREAM PORTION OF BARANGAYS CABETICAN AND TINAJERO, BACOLOR, PAMPANGA, TO WIT:

- 1. EXCAVATION/CHANNEL IMPROVEMENT OF PASIG-POTRERO RIVER (STA. URSULA PORTION) AND REMOVAL OF OLD AND DETERIORATING BAILEY BRIDGE
- 2. OPENING OF MINALIN CHECK GATE
- 3. EXCAVATION OF CAMACHILES CHANNEL DOWNSTREAM OF BARANGAYS TINAJERO AND CABETICAN
- 4. CONSTRUCTION OF SLOPE PROTECTION OF MINALIN TAIL DIKE RIGHT BANK (LENGTH = 3.7KM) TALBA AND TINAJERO PORTION
- 5. CONSTRUCTION OF SLOPE PROTECTION ALONG CABETICAN TINAJERO CREEK (LENGTH = 1.48 KM)

WHEREAS, during the onset of Southwest monsoon rains, commonly known as Habagat, continuous heavy downpour has triggered widespread flooding along low lying barangays of Bacolor particularly Barangays Cabetican and Tinajero;

**WHEREAS**, heavy siltation along major river tributaries, alongside the incomplete construction of vital anti-flooding infrastructures, have unabatedly caused the back flowing of huge volume of floodwaters resulting to the submersion of low-lying communities in aforementioned barangays;

**NOW THEREFORE**, the Sangguniang Bayan of Bacolor in an online session assembled, upon motion of Hon. Ariel C. Sta. Cruz, duly seconded by Hon. Ener C. Lampa;

**RESOLVED AS IT IS HEREBY RESOLVED**, to request Engr. Roseller A. Tolentino, Regional Director, Department of Public Works and Highways (DPWH) Region III to provide an assistance on the following infrastructure projects to address the problem on perennial flooding at the downstream barangays Cabetican and Tinajero, Bacolor, Pampanga, to wit: 1. Excavation/Channel improvement of Pasig-Potrero River (Sta. Ursula Portion) and Removal of old Bailey Bridge, 2. Opening of Minalin Check Gate, 3. Excavation of Camachilles Channel downstream of Barangays Tinajero and Cabetican, 4. Construction of slope protection of Minalin Tail Dike Right Bank (Length = 3.7km) Talba and Tinajero portion, 5. Construction of slope protection of Cabetican – Tinajero Creek (Length = 1.48 km);

**RESOLVED FINALLY**, that a copy of this resolution be furnished Engr. Roseller A. Tolentino, Regional Director, Department of Public Works and Highways (DPWH) Region III, Hon. Eduardo G. Datu, Municipal Mayor for their ready reference.
