A RESOLUTION APPROVING THE UTILIZATION OF THE AMOUNT OF THREE MILLION TWO HUNDRED TWENTY THREE THOUSAND EIGHT HUNDRED EIGHTY PESOS AND FORTY CENTAVOS (P3,223,880.40), REPRESENTING THE FINANCIAL BENEFITS TO HOST COMMUNITIES/LOCAL GOVERNMENT UNITS EXTENDED BY THE DEPARTMENT OF ENERGY PURSUANT TO ENERGY AMENDED. REGULATIONS 1-94. AS FOR THE **ESTABLISHMENT** QUARANTINE/ISOLATION/VACCINATION FACILITIES WITH MEDICAL SUPPLIES AND EQUIPMENTS, PERSONAL PROTECTIVE EQUIPMENTS (PPES), FACILITIES PARAPHERNALIA, MEDICINES AND FOOD SUPPLIES AND FOR THE MAINTENANCE OF THESE FACILITIES, WHICH IS IN ACCORDANCE WITH THE DEPARTMENT OF ENERGY DEPARTMENT CIRCULAR NO.
