**A RESOLUTION AUTHORIZING HON. EDUARDO G. DATU, MUNICIPAL MAYOR, FOR AND IN BEHALF OF THE MUNICIPALITY OF BACOLOR, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE PROVINCE OF PAMPANGA, REPRESENTED BY ITS GOVERNOR, HON. DENNIS G. PINEDA, FOR THE PROVISION OF FINANCIAL ASSISTANCE BY THE PROVINCE OF PAMPANGA TO THE MUNICIPALITY OF BACOLOR, AS AID TO MUNICIPALITIES OF PAMPANGA, FOR THE FY 2021, IN THE AMOUNT OF FIVE MILLION PESOS (P5,000,000.00) FOR THE PURCHASE OF HEAVY EQUIPMENT**

**WHEREAS**, under Section 16. General Welfare of the Local Government Code of 1991, provides that: Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdictions, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants;

**WHEREAS**, the Municipal Mayor requested the Sangguniang Bayan thru his letter dated August 18, 2021 to authorize him, for and in behalf of the Municipality of Bacolor, Pampanga, to enter into a Memorandum of Agreement (MOA) with the Province of Pampanga, represented by its Governor, Hon. Dennis G. Pineda, for the provision of financial assistance by the Province of Pampanga to the Municipality of Bacolor, as Aid to Municipalities of Pampanga, for the FY 2021, in the amount of Five Million Pesos (P5,000,000.00) for the purchase of heavy equipment

**WHEREAS**, the following are the obligations agreed by both parties:

**OBLIGATIONS OF THE FIRST PARTY (Provincial Government):**

1. Provide financial assistance to the SECOND PARTY in the form of fund transfer amounting to FIVE MILLION PESOS (P5,000,000.00) for the implementation of its project proposals approved by the Governor and appended hereto as Annex "A" and made integral part hereof.
2. Provide briefing to the SECOND PARTY prior to the release of fund assistance to ensure that both the technical and administrative concerns relative to the approved project proposals are adequately addressed.
3. Monitor project implementation through a committee to be created by the Governor composed of members of the executive and legislative departments of the FIRST PARTY.

4. Institute appropriate actions against the SECOND PARTY which may include, among others, suspension or termination of the project and/or the return of the amount in case of violation of the provisions of the MOA and/or legal action for misuse of approved and released funds, the legal costs of which shall be shouldered by the SECOND PARTY.

**OBLIGATIONS OF THE FIRST PARTY (Municipality of Bacolor):**

1. Implement the approved project proposals based on the approved Program of Work to achieve the objectives it is committing itself and in accordance with approved standards, systems and procedures for project implementation, time schedule, as well attached approved budget estimates contained in the approved program;
2. Utilize the amount received solely for the above-mentioned project and/or for the purpose as specified in the project proposal.
3. Shall not use the funds for money market placement, time deposit and other forms of investments not related to the project.
4. Keep and maintain separate financial and accounting records for the funds received from the FIRST PARTY in accordance with generally accepted accounting principles.
5. Submit a liquidation report duly verified by the Commission on Audit and supported by accomplishment report, pictures and other documents to support the project implementation.
6. Return any amount not utilized immediately upon completion of the project.
7. Allow access to or make available its records and facilities for visitorial audit and examination of the FIRST PARTY and/or the COA authorized representatives.
8. Advice and secure written approval from FIRST PARTY for any major changes/deviations from the approved project proposal. In case of unauthorized deviations or alterations in the implementation of the approved project proposal, the SECOND PARTY shall shoulder all necessary cost and expenses.

**NOW THEREFORE**, the Sangguniang Bayan of Bacolor in an online session assembled, upon unanimous motion;

**RESOLVED AS IT IS HEREBY RESOLVED**, to authorize Hon. Eduardo G. Datu, Municipal Mayor, for and in behalf of the Municipality of Bacolor, to enter into a Memorandum of Agreement (MOA) with the Province of Pampanga, represented by its Governor, Hon. Dennis G. Pineda, for the provision of financial assistance by the Province of Pampanga to the Municipality of Bacolor, as Aid to Municipalities of Pampanga, for the FY 2021, in the amount of Five Million Pesos (P5,000,000.00) for the purchase of heavy equipment;

**RESOLVED FINALLY**, that a copy of this resolution be furnished Hon. Dennis G. Pineda, Governor, Province of Pampanga and Hon. Eduardo G. Datu, Municipal Mayor for their ready reference.
