A RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 01, S-2021 – AN ORDINANCE APPROPRIATING FUNDS FROM THE SAVING (UNUSED FUNDS FROM 2020) AMOUNTING TO FOUR HUNDRED THIRTY SIX THOUSAND TWO HUNDRED SIXTY SIX PESOS AND EIGHTY CENTAVOS (P436,266.80) AND TO BE APPROPRIATED TO MAINTENANCE AND OTHER OPERATING EXPENSES FOR THE YEAR 2021 OF THE SANGGUNIANG KABATAAN OF CABALANTIAN, BACOLOR, PAMPANGA
