A RESOLUTION EARNESTLY REQUESTING ENGR. ALMER C. MIRANDA, DISTRICT ENGINEER, DEPARTMENT OF PUBLIC WORKS & ENGINEERING (DPWH) REGION III TO CONDUCT A CLEARING OPERATION AND VEGETATION CONTROL THAT CAUSE OBSTRUCTION ALONG THE FVR MEGADIKE/EAST LATERAL MEGADIKE TO AVOID ACCIDENT ON THE MOTORISTS.

WHEREAS, under Section 16 of the Local Government Code specifically provided in the General Welfare Clause. Every Local Government Unit shall ensure and support, among other things, the promotion of health and safety essential to the promotion of the general welfare within their respective jurisdictions;

WHEREAS, presented for consideration the second request of Hon. Danlohp D. Danganan, Pambansang Pederasyon ng mga Sangguniang Kabataan (PPSK) Chairman to clear FVR Megadike by clearing of vegetation and big grass extending to the main road that caused obstruction to the motorist;

WHEREAS, numerous incidents of vehicular accidents were reported and clamors of motorist were elevated to the municipal offices that needs preferential attention and immediate action;

WHEREAS, the aforesaid request be considered urgent so not put danger and risk on the lives of the motorists;


