**A RESOLUTION APPROVING THE ANNUAL INVESTMENT PROGRAM (AIP) FOR CY 2022 OF THE CONSISTING OF PRIORITY PROGRAMS/PROJECTS TO BE FUNDED UNDER THE 20% ECONOMIC DEVELOPMENT FUND (EDF) AMOUNTING TO THIRTY NINE MILLION ONE HUNDRED NINETY TWO THOUSAND EIGHT HUNDRED FOURTEEN PESOS AND SIXTY CENTAVOS (P39,192,814.60) AND THOSE TO BE FUNDED BY EXTERNAL SOURCES AMOUNTING TO ONE BILLION NINE HUNDRED FIFTY NINE MILLION FIVE HUNDRED THOUSAND PESOS (P1,959,500,000.00) OR AN AGGREGATE AMOUNT OF ONE BILLION NINE HUNDRED NINETY EIGHT MILLION SIX HUNDRED NINETY TWO THOUSAND EIGHT HUNDRED FOURTEEN PESOS AND SIXTY CENTAVOS (P1,998,692,814.60) FOR BOTH 20% EDF AND EXTERNAL SOURCES**

**RESOLVED AS IT IS HEREBY RESOLVED**, that the Annual Investment Program (AIP) for CY 2022 of the consisting of priority programs/projects to be funded under the 20% Economic Development Fund (EDF) amounting to Thirty Nine Million One Hundred Ninety Two Thousand Eight Hundred Fourteen Pesos and Sixty Centavos (P39,192,814.60) and those to be funded by External Sources amounting to One Billion Nine Hundred Fifty Nine Million Five Hundred Thousand Pesos (P1,959,500,000.00) or an aggregate amount of One Billion Nine Hundred Ninety Eight Million Six Hundred Ninety Two Thousand Eight Hundred Fourteen Pesos and Sixty Centavos (P1,998,692,814.60) for both 20% EDF and External Sources is approved in accordance with the requirements set forth under the Local Government Code.


**RESOLVED FINALLY**, that a copy of this resolution be furnished the Local Development Council of the Municipality of Bacolor, Pampanga.


