Resolution No. 154, S-2021

A RESOLUTION AUTHORIZING HON. EDUARDO G. DATU, MUNICIPAL MAYOR, FOR AND IN BEHALF OF THE MUNICIPALITY OF BACOLOR, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH DEPED DIVISION OF PAMPANGA, REPRESENTED BY ITS SCHOOLS DIVISION SUPERINTENDENT, ENGR. EDGARD C. DOMINGO,PHD, CESO V, FOR THE ESTABLISHMENT OF THE PROPOSED TINAJERO INTEGRATED SCHOOL

WHEREAS, the Local Government of Bacolor top priority program is to provide quality and affordable education to all Bacoloreños;

WHEREAS, most of our Cabalens have returned back to their own residences in Bacolor. Don Honorio Ventura Technological State University (DHVTSU) and Bacolor High School can no longer cater the growing number of enrollees every year;

WHEREAS the DepEd Division of Pampanga is in need of additional secondary school, particularly within the catchment area of Barangay Tinajero and Talba Municipality of Bacolor to accommodate 190 or more prospective enrollees;

WHEREAS, the establishment of the proposed TINAJERO INTEGRATED SCHOOL is considered an urgent need in Barangay Tinajero Bacolor, Pampanga of as indicated in the project feasibility;

WHEREAS, the Municipal Mayor requested the Sangguniang Bayan thru his letter dated November 29, 2021 to authorize him, for and in behalf of the Municipality of Bacolor, Pampanga, to enter into a Memorandum of Agreement (MOA) with DepEd Division of Pampanga, represented by its Schools Division Superintendent, Engr. Edgard C. Domingo,PhD, CESO V, for the establishment of the proposed Tinajero Integrated School;

WHEREAS, the following are the responsibilities of the parties:

ROLES AND RESPONSIBILITIES OF DEPED:

1. The DepEd shall ensure the issuance of DepED School in the name of TINAJERO INTEGRATED SCHOOL;
2. The DepEd shall spearhead the implementation of the school's education curriculum;
3. The DepEd shall work for the school's funding requirements for Personal Services, Maintenance and Other Operating Expenses, and Capital Outlay in the General Appropriations Act, and the subsequent issuance of Agency Code;
4. The DepEd shall request for the creation of vital positions, both teaching and non- teaching, to the Department of Budget and Management (DBM), through the DepEd Regional and Central Offices;

5. The DepEd shall ensure the designation of an Officer-in-Charge of the TINAJERO INTEGRATED SCHOOL and eventually the appointment of a School Head who possesses the necessary qualifications pursuant to DepEd, DBM and CSC applicable rules and regulations; and
6. The DepEd shall monitor the operation of the TINAJERO INTEGRATED SCHOOL

ROLES AND RESPONSIBILITIES OF THE MUNICIPALITY OF BACOLOR:

The LGU shall provide funds for the TINAJERO INTEGRATED SCHOOL among others, the following:

1. Construction of the new school buildings;
2. Procurement of educational facilities, furniture and instructional materials;
3. Operation and maintenance for at least five (5) years or until such time when funds for the purpose are incorporated in the national budget; and
4. Salaries of teaching and non-teaching personnel, preferably at par with national salary rates.
5. Continue to provide financial assistance through the Special Education Fund.

NOW THEREFORE, the Sangguniang Bayan of Bacolor in session assembled, upon motion of Hon. Voltaire J. San Pedro, unanimously seconded;

RESOLVED AS IT IS HEREBY RESOLVED, to authorize Hon. Eduardo G. Datu, Municipal Mayor, for and in behalf of the Municipality of Bacolor, to enter into a Memorandum of Agreement (MOA) with DepEd Division of Pampanga, represented by its Schools Division Superintendent, Engr. Edgard C. Domingo, PhD, CESO V, for the establishment of the proposed Tinajero Integrated School;


