A RESOLUTION APPROVING BARANGAY APPROPRIATION ORDINANCE NO. 01, S-2021 – AN ORDINANCE APPROPRIATING FUNDS FROM THE EXCESS OF ACTUAL COLLECTION AS OF OCTOBER 31, 2021 AMOUNTING TO TWO MILLION SIX HUNDRED FIFTY ONE THOUSAND NINE HUNDRED FORTY PESOS (P2,651,940.29) AND TO BE APPROPRIATED TO PERSONAL SERVICES, BASIC SERVICES, MAINTENANCE AND OTHER OPERATING EXPENSES AND CAPITAL OUTLAY FOR THE YEAR 2021 OF BARANGAY BALAS, BACOLOR, PAMPANGA
